Booking Conditions for groups:

A £20.00 non-refundable booking deposit must be paid for each pitch booked. If a pitch is cancelled giving over 48 hours notice then this can be taken off the remainder of the groups balance. If less than 48 hours notice is given, the balance of the cancelled pitch will remain on the balance of the remaining booking. In the event of the whole booking being cancelled, giving more than 48 hours notice, the deposits can be transferred to a period during the low season. If less than 48 hours notice is given for the cancellation of the whole booking, we reserve the right to charge the remaining balance to the organiser. **The deposit payment must be made in one transaction, as must the balance payment on arrival.** Final confirmation of numbers must be made no less than 48 hours in advance of the date of your arrival. No changes to the overall fee can be made after this date.

Bookings are accepted in good faith, however if the reality of the booking differs from what has been stated above, we may cancel bookings on arrival or at any time during your visit. Please see our general site rules and restrictions regarding groups. A bond against noise or damage may be required on arrival up to £25.00 per head. (Discretionary)

Single sex groups of more than 2 people will not be permitted onto the park. A maximum of 4 adults to a booking unless part of a family group (parents with their children) Charitable or educational groups may be exempt with prior consent.

Swiss Farm restricts the numbers of customers staying on any night to what we regard to be a comfortable limit. It is therefore not always possible to increase the numbers of pitches booked or the numbers of people within a booking once a booking has been made.

The size of group bookings is limited according to the nature of the booking and the level of trade during that period. This is done to avoid disrupting other guests on holiday. It is for this reason that we do not allow separate group bookings to join up on the park or for other types bookings to join up with group bookings. If group bookings are expanded in this way then we reserve the right to cancel all bookings involved with immediate effect with no recourse to refunds.

It is required for all our guests to have the highest regard for the comfort of those sharing the parks facilities. Special attention must be given to the following points:

Children must be accompanied by an adult at all times whilst on the park.

Dogs (when permitted on site) must be kept on a lead at all times and any mess cleaned up and disposed of appropriately. We no longer accept dogs during High and Peak Season. Dogs on the dangerous dogs list are also not permitted. Please ask if unsure.

Radios are not permitted at any time. Please keep televisions at a sensible level.

There should be very little noise after 10pm and no noise after 11pm.

BBq's are welcomed but strictly no open fires or fire drums. If you are unsure then please ask for a definition.

Please observe the parks speed limit of 5MPH at all times.

Drunken, disorderly, abusive or inappropriate behaviour of any description will result in an immediate ejection from the park. With regard to drink driving laws, we are a public space and the same laws apply as on the roads. Anyone found using alcohol whilst in charge of a vehicle will be reported to the police.

Main points:

1. Full payment must be made on arrival by the signatory. No split payments please.
2. Tents, trailer tents and private cars only please. No commercial vehicles. This includes all vans. Please ask before booking if you require clarification.
3. Deposits are non refundable.
4. We do not refund early departures.
5. It is the responsibility of the signatory to inform each family of our rules and booking conditions.
6. Please make sure you book each family under their correct name and they also know **your** surname.
7. There is no charge for payments by Debit card or cash however a 3% charge will be made on Credit card payments
8. A £10.00 **cash** deposit will be needed from each family on arrival for a refundable barrier card deposit
9. Gas and charcoal BBq's are welcomed however we do not allow open fires.
