



## Swiss Farm International Touring and Camping Park

Please read the following carefully:

Swiss Farm operates an electronic barrier system for the safety of its customers, which requires a swipe pass. Each card carries a deposit of £10.00 (Returnable on departure). Customers are requested to return cards during office hours to guarantee return of deposits. This barrier restricts vehicle access to the park between Midnight and 7am.

If you should wish to leave the park before 9am please talk to a member of reception staff. A Height Barrier also restricts vehicles above 6ft 8" between 10pm and 8am (9am on Sundays)

BBQ's are very welcome on the park but must be raised off the ground and extinguished properly when finished. **Open fires are strictly forbidden.** If you are unsure of the distinction please talk to a member of staff.

Dogs are welcome during the **low season** but must be kept on leads and picked up after at all times. We are surrounded by farmland that is often used by livestock.

All visitors must sign in at reception and pay for a day pass, enabling them to use the sites facilities. (This does not include the Swimming Pool.) Those wishing to stay the night must pay normal camping charges.

To avoid disappointment it is advisable to check which facilities are available during your stay.

Please, at all times have consideration for other campers and use common sense with regard to music volumes etc. No music after 10pm. Noise complaints will be taken very seriously and may result in removal from the park.

**No Groups** (Single Sex or Mixed) Except for organised educational groups i.e. D of E award scheme or similar. Customers joining up on site to form a group without the permission and/or knowledge of the park management will have their bookings cancelled with immediate effect.

Only 1 Caravan, 1Awning and 1 Car are permitted on each pitch. (Commercial vehicles are not permitted on the site) For additional vehicles/pup tents etc. please talk to a member of staff.

Only electrical equipment that is specifically designed for use in caravans may be used, this is especially important with Kettles, Microwaves, outdoor lights and cookers. Heedless overloading of the system will result in power failure and discomfort for other people.

The use of Electric Heaters is strictly forbidden. Each pitch is metered. We allow £1.00 of electric per night within your fees. Customers going over their allocation may be charged.

Customers use the park entirely at their own risk. The management cannot be held responsible for any damage or theft of vehicles or personal belongings. Customers are required to have their own insurance cover.

Swiss Farm reserves the right to remove and destroy / re-sell caravans or other property that is left on site without permission or if customers fail to maintain payments. (Subject to a 14-day private land notice)

Failing to adhere to any of the above may result in removal from the site.
